

Terms of use GoHere

Important

Please read these Terms of Use carefully before using GoHere offered by Appfocus B.V. ("GoHere"), a company registered in the Netherlands. These terms of use set forth the legally binding terms and conditions for your use of the website at <https://www.gohereapp.com> and the GoHere Android and iOS apps and features, content, applications or widgets offered by GoHere.

Acceptance of Terms

By registering for and/or using GoHere in any manner, including but not limited to visiting or using the app or website (From now on referred to as The Platform), you agree to all of the terms and conditions contained herein ("Terms of Use") and all other operating rules, policies and procedures that may be published from time to time on The Platform by GoHere, each of which is incorporated by reference and each of which may be updated by GoHere from time to time without notice to you in accordance with the terms set out under the "Modification of Terms of Use" section below. In addition, some services offered through GoHere may be subject to additional terms and conditions specified by GoHere from time to time; your use of such services is subject to those additional terms and conditions, which are incorporated into these Terms of Use by this reference. These "Terms of Use" apply to all users of GoHere, including, without limitation, users who are contributors of content, information, and other materials or services on The Platform, individual users of GoHere, businesses that access GoHere.

Content

Governing Law

A printed version of these Terms of Use and of any notice given in electronic form shall be admissible in judicial or administrative proceedings based upon or relating to these Terms of Use to the same extent and subject to the same conditions as other business documents and records originally generated and maintained in printed form. You and GoHere agree that any cause of action arising out of or related to GoHere must commence within one (1) year after the cause of action arose; otherwise, such cause of action is permanently barred. These Terms of Use and any disputes or claims arising out of or in connection with it shall be governed by, and construed in accordance with, the laws of The Netherlands. All disputes or claims arising out of or relating

to these Terms of Use shall be subject to the exclusive jurisdiction of the Court in Amsterdam to which the Parties irrevocably submit.

Integration and Severability

These Terms of Use are the entire agreement between you and GoHere with respect to GoHere and use of the Platform, Service, Content and User Submissions, and supersede all prior or contemporaneous communications and proposals (whether oral, written or electronic) between you and GoHere with respect to The Platform. If any provision of these Terms of Use is found to be unenforceable or invalid, that provision will be limited or eliminated to the minimum extent necessary so that these Terms of Use will otherwise remain in full force and effect and enforceable.
